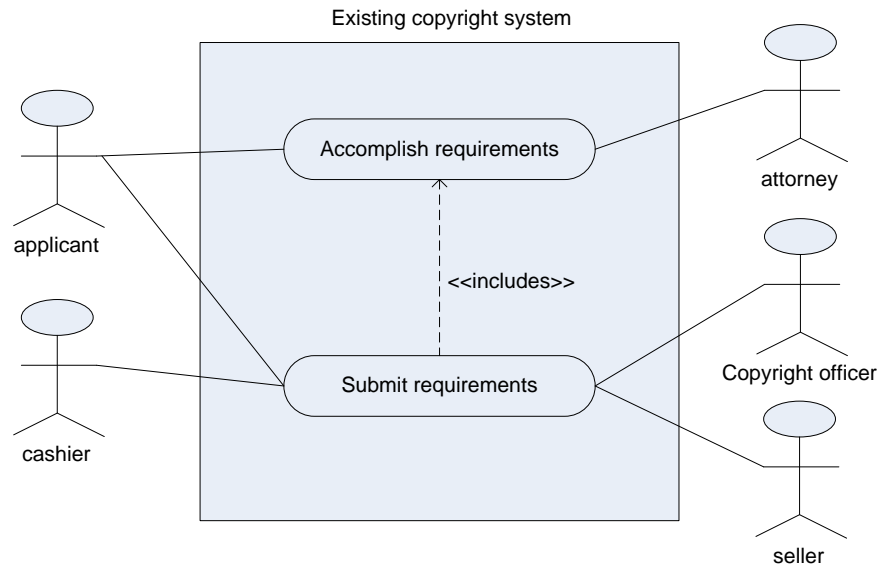

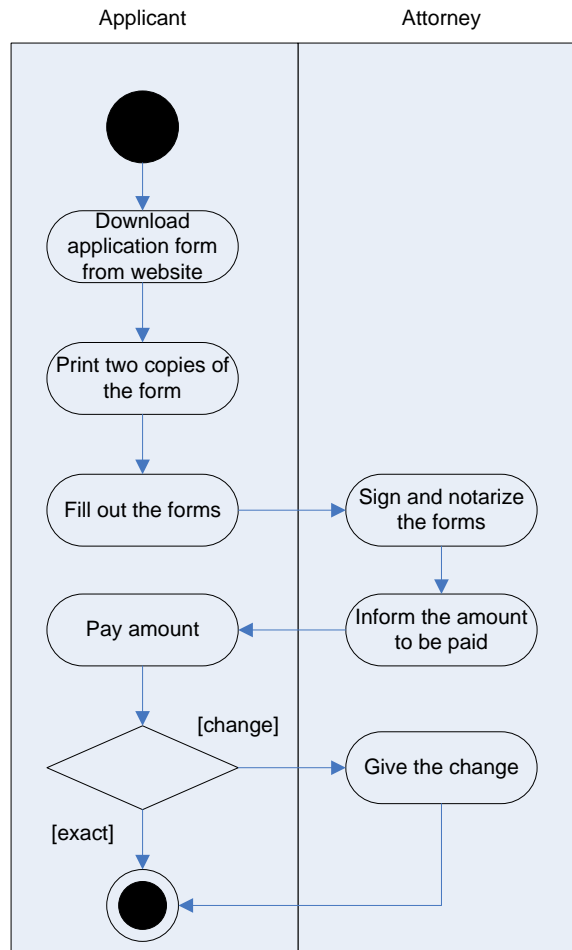
Existing Copyright system

Use case Narrative

Identification summary

Title: Accomplish requirements

Summary: a use case wherein the applicant accomplishes the requirements for applying for a copyright which includes notarizing of application forms

Actors: Applicant, attorney

Version: 1.0

Creation date: Feb 26, 2010

Person in charge: Jose Miguel Gamba

Flow of events

Precondition: The work being applied for copyright is printed with two copies

Main Success scenario:

- 1) The applicant downloads the application form from the copyright website
- 2) The applicant prints two copies of the application form
- 3) The applicant fills out the application forms then submits it to an attorney for notarization

- 4) The attorney appends his signature and notarize the forms
- 5) The attorney informs the applicant the amount to be paid for the notarized forms
- 6) The applicant pays the amount
- 7) Use case successfully

Alternative scenario:

- A1. 1) The applicant gives money exceeding the amount to be paid
- 2) The attorney gives the change
- 3) Use case ends successfully

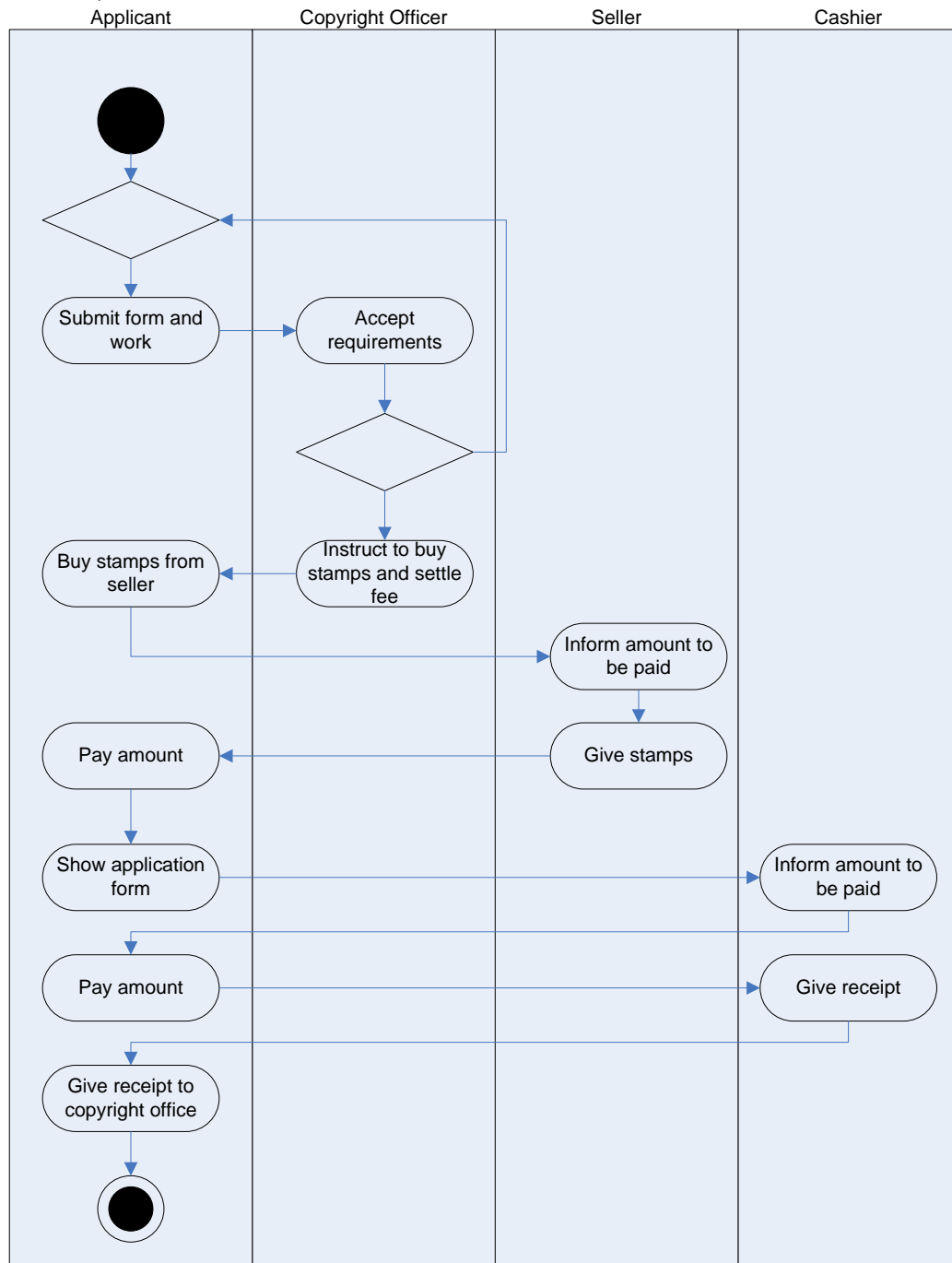
Error sequence

- E1. 1) The applicant filled out the form incorrectly
- 2) The applicant will need to print a new copy of the application form
- 3) Use case fails

Post conditions

- 1) The applicant is now ready to submit the requirements to the copyright office
- 2) The application form is notarized

Title: Submit requirements

Summary: a use case wherein the applicant submits the requirements for copyright application

Actors: Applicant, copyright officer, seller, cashier

Version: 1.0

Creation date: Feb 26, 2010

Person in charge: Jose Miguel Gamba

Flow of events

Precondition: The applicant's requirements must be complete and must be in an envelope with proper identification

Main success scenario:

- 1) Applicant submits works and application forms to the copyright officer
- 2) The copyright officer accepts the works and applications forms then instruct the applicant to buy two stamps
- 3) The applicant proceeds to the seller to buy two stamps
- 4) The seller informs the applicant of the amount to be paid
- 5) The applicant pays the amount for two stamps then proceeds to the cashier
- 6) The applicant shows the copyright application form to the cashier
- 7) The cashier informs the applicant of the amount to be paid
- 8) The applicant pays the amount for the copyright
- 9) The cashier gives the receipt
- 10) The applicant shows the receipt to the copyright officer
- 11) Use case ends successfully

Alternative sequence

- A1. 1) The applicant will give money exceeding the required amount
- 2) The cashier will give the change
 - 3) Use case ends successfully

Error sequence

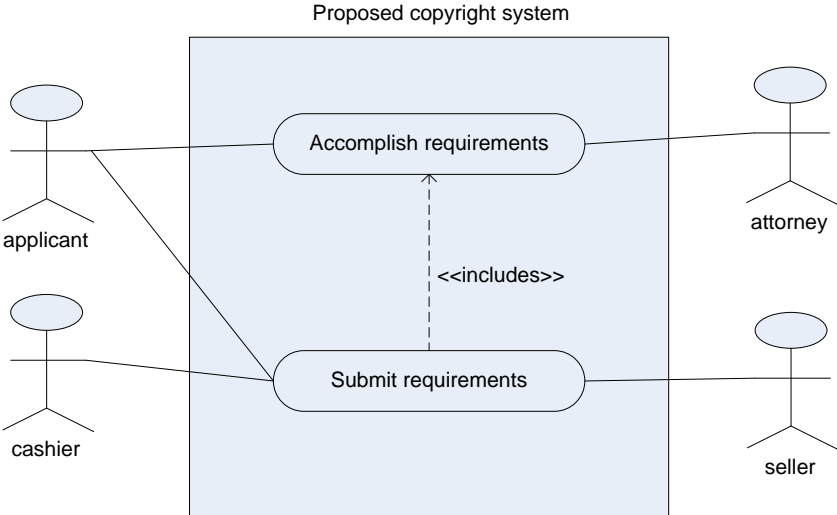
- E1. 1) There is no available stamp
- 2) Use case fails

Post condition

- 1) The applicant will wait for 1 month to claim his copyrighted work

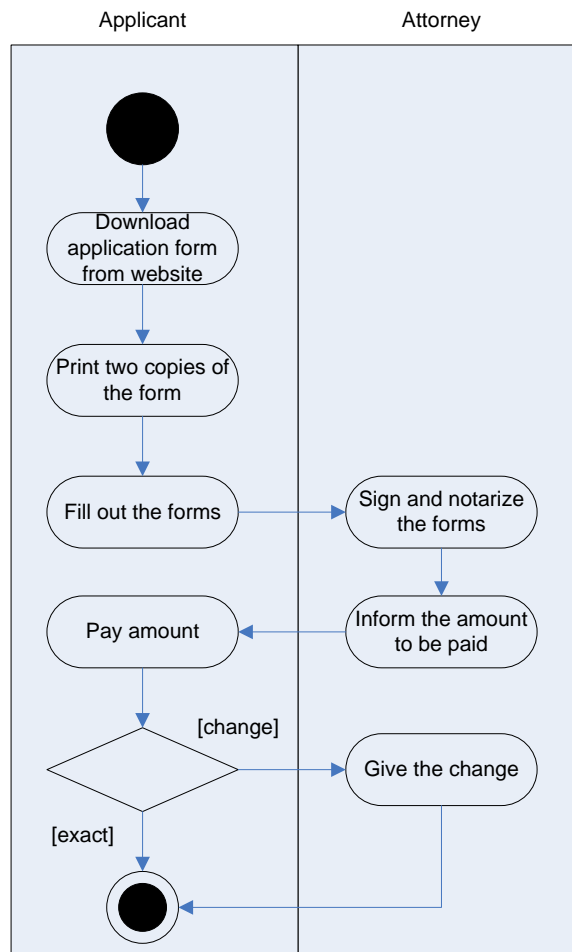
Proposed copyright system

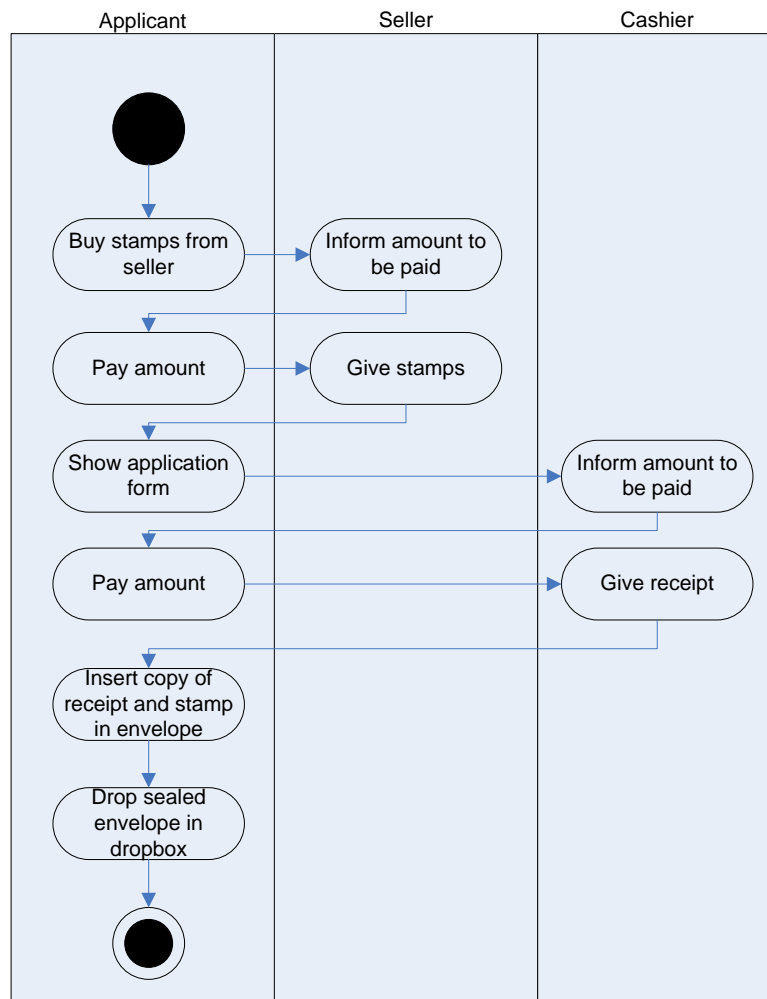

Person in charge: Jose Miguel Gamba

Flow of events

Precondition: The work being applied for copyright is printed with two copies

Main Success scenario:

- 1) The applicant buys two stamps from the seller

- 2) The seller informs the applicant the amount to be paid
- 3) The applicant pays the amount
- 4) The seller gives the stamps then the applicant proceeds to the cashier
- 5) The applicant shows the copyright application form to the cashier
- 6) The cashier informs the applicant the amount to be paid
- 7) The applicant pays the amount
- 8) The cashier gives the applicant the receipt
- 9) The applicant compiles his work, application form, and receipt into a short brown envelope
- 10) The applicant drops the envelope on a drop box located at the national library
- 11) Use case end successfully

Alternative scenario:

- A1. 1) The applicant gives money exceeding the amount to be paid
- 2) The attorney gives the change
- 3) Use case ends successfully

Error sequence

- E1. 1) There are no available stamps
- 2) Use case fails

Post conditions

- 1) The applicant waits for 1 month then goes to the copyright office to claim his copyrighted work
